CONDITIONAL USE APPLICATIONS: Please complete the Analysis Requirements questionnaire. Applicants are required to respond to criteria 1 through 8; also 13, and 18 through 22. Criteria 9 through 12, and 14 through 17, and 23 are NOT required to be completed for a Conditional Use Application.

- 1. Whether the proposal will permit a use that is suitable in view of the use and development of adjacent and nearby property. The property is currently being used as a shopping center. The purpose of this application is to request that Alpine Bakery and Pizzeria, a current tenant, be allowed to expand for the sole use of adding a dining area for on-premises consumption. Since this is an existing tenant this added use will have no effect on adjacent or nearby properties.
- Whether the proposal will adversely affect the existing use or usability of adjacent or nearby property. As previously stated, the requested use is for a current tenant, the use of the tenant is not changing, there is no structural or major change to the structure on the property and therefore there will be no adverse affect to the use or usability of adjacent or nearby properties.
- 3. Whether the property to be affected by the proposal has a reasonable economic use as currently zoned. The current use will be severely impacted if Alpine Bakery is not allowed to sell for on-premise consumption. This tenant will vacate the property which in addition to a loss for the property owner will also produce a tax revenue loss to the City of Roswell and further a loss for the services Alpine provides to the community.
- 4. Whether the proposal will result in a use which would or could cause an excessive or burdensome use of existing streets, transportation facilities, utilities, or schools.
 No, the clientele will be the same, no excessive burden will be created on the streets, transportation, utilities or schools, since the only addition to the property would be seating.





- 5. Whether the proposal is in conformity with the policy intent of the Comprehensive Plan including land use element. There is no change in the land use element and therefore in conformity with the Comprehensive Plan.
- 6. Whether there are other existing or changing conditions affecting the use and development of the property which give supporting grounds for either approval or disapproval of the proposal. Alpine Bakery and Pizzeria is an existing tenant currently selling baked good and pizza to its patrons, the purpose of this application is to allow those patrons who are already at the property to consume the baked goods and/or pizza on the premises.

An applicant for an amendment to the official zoning map may decline to provide any information related to criteria seven (7) through twenty-three (23) if he or she completes, signs, and notarizes the following statement: "I do not regard the information required by the City, or any portion thereof as indicated, as necessary or

- 1. There are extraordinary and exceptional conditions or practical difficulties pertaining to the particular piece of property in question because of its size, shape, topography that are not applicable to other lands or structures in the same district.
- 2. Any information whereby a literal interpretation of the provisions of this ordinance would effectively deprive the applicant of rights commonly enjoyed by other properties of the district in which the applicant's property is located.
- Any information supporting that granting the variance requested will not confer upon the property
 of the applicant any special privileges that are denied to other properties of the district in which the
 applicant's property is located.
- 4. Any information that the requested variance will be in harmony with the purpose of the intent of this ordinance and will not be injurious to the neighborhood or to the general welfare.
- 5. Any information that special circumstances are not the result of the actions of the applicant.
- 6. Any information that the variance request is the minimum variance that will make possible the proposed use of the land, building, or structure in the use district proposed.
- 7. Any information that the variance shall not permit a use of land, buildings, or structures, which is not permitted by right in the zoning district or overlay district involved.

CODE OF GEORGIA TITLE 36. LOCAL GOVERNMENT PROVISIONS APPLICABLE TO COUNTIES AND MUNICIPAL CORPORATIONS CHAPTER 67A. CONFLICT OF INTEREST IN ZONING ACTIONS (Current through 2000 General Assembly)

36-67A-3 Disclosure of campaign contributions.

- a) When any applicant for rezoning action has made, within two years immediately preceding the filing of that applicant's application for the rezoning action, campaign contributions aggregating \$250.00 or more to a local government official who will consider the application, it shall be the duty of the applicant to file a disclosure report with the governing authority of the respective local government showing:
 - 1) The name and official position of the local government official to whom the campaign contribution was made; and
 - 2) The dollar amount and description of each campaign contribution made by the applicant to the local government official during the two years immediately preceding the filing of the application for the rezoning action and the date of each such contribution.
- b) The disclosures required by subsection (a) of this Code section shall be filed within ten days after the application for the rezoning action is first filed.
- c) When any opponent of a rezoning action has made, within two years immediately preceding the filing of the rezoning action being opposed, campaign contributions aggregating \$250.00 or more to a local government official of the local government which will consider the application, it shall be the duty of the opponent to file a disclosure with the governing authority respective local government showing:
 - 1) The name and official position of the local government official to whom the campaign contribution was made; and
 - 2) The dollar amount and description of each campaign contribution made by the opponent to the local government official during the two years immediately preceding the filing of the application for the rezoning action and the date of each such contribution.
- d) The disclosure required by subsection (c) of this Code section shall be filed at least five calendar days prior to the first hearing by the local government of any of its agencies on the rezoning application.
