**RESOLUTION TO ACCEPT THE PY2014 COMMUNITY DEVELOPMENT BLOCK
GRANT (CDBG) AWARD**

WHEREAS, at the regular meeting of the Mayor and City Council of Roswell, Georgia, held on the 28th of April, 2014, a motion was made and duly seconded that the City of Roswell, Georgia agrees to accept the PY14 Community Development Block Grant (CDBG) award from the U.S. Department of Housing and Urban Development (HUD);

WHEREAS, the grant award shall be in the amount of \$431,921 in federal funds for the purpose of providing funding to viable communities for decent housing, suitable living environments and economic opportunities, principally for persons of low and moderate income;

WHEREAS, the CDBG funds will be allocated as specified in the table below, pending HUD's approval of the City's 2014 Annual Action Plan;
