TO: ROSWELL MAYOR JERE WOOD AND CITY COUNCIL MEMBERS

We, the undersigned residents of the City of Roswell, Georgia, attest that we are in opposition to the installation of T-Mobile's 108 foot monopole tower on or adjacent to the property located at 1060 Lake Charles Drive, Roswell, Georgia, 30075, and call on the city council to deny T-Mobile's application. Impacted residents in these neighborhoods have good cell phone reception with other carriers. Further, the proposed installation of the cellular monopole and antenna is inconsistent with the character of the neighborhoods surrounding this location. We encourage the City of Roswell to suggest alternative locations, particularly those where towers already exist, where the City may benefit financially, and to protect against blight to our neighborhoods, devaluation of properties within our community, and potential health risks.

Please encourage T-Mobile and other cellular communications companies to locate in nearby commercial and industrial zones away, where their competitors are able to provide adequate services. This is consistent with FCC directives providing for access to towers (or other) already erected.
