Mayor's Report

1. Reading of a Proclamation Honoring and Recognizing
Recreation and Parks, Historic and Cultural Affairs Director
Joe Glover upon his retirement from the City of Roswell

Mayor Wood proclaimed November 7, 2014 as Joe Glover Day to honor and recognize his commendable career and congratulate him for his 36 years serving the City of Roswell and retiring after 47 years of service in the recreation field.

2. Reading of a Proclamation for America Recycles Day

Mayor Wood read a proclamation for America Recycles Day (a program of Keep America Beautiful) which is celebrated nationwide every November 15 and is dedicated to promoting recycling in America.

3. Reading of a Proclamation for Administration and Finance Appreciation Week

Mayor Wood proclaimed October 27, 2014 through October 31, 2014 as Administration and Finance Week to recognize the talents and dedication of the employees of these two departments who provide excellence in customer service and maintain the highest standards in support of the City's strategic goals.

4. Approval of a Roswell Arts Commission Appointment - Lawrence Catchpole

The City intends to install two dual EV charging stations at City Hall; one dual station at the Roswell Area Park - Physical Activity Center; and one dual station at the East Roswell Park. 6. Approval of a Resolution to Submit a 2013-2014 Recreational Trails Program Grant Application seeking \$100,000 in Federal Funds for the Old Mill Ruins Park Trail Phase III Project

A motion was made by Council Member Igleheart, seconded by Council Member Orlans, that this Resolution to submit this grant application be approved. The Old Mill Ruins Parks Trail Phase 3 includes the expansion of the existing trail system to incorporate pedestrian and Americans with Disabilities Act (ADA) trail access via boardwalks and overlooks. This allows additional connectivity to more historic mill ruins, which are located to the right of the covered bridge. This project is identified in the 5 Year Strategic Master Plan. Currently, there are 3 staff positions in the Special Events Division: One full time Special Events Manager, one part time Volunteer Coordinator and one part time Administrative Assistant for special event permitting. The reorganization will eliminate the part time Administrative Assistant position (permitting) and move the part time Volunteer Coordinator position to a full time Event/Volunteer Coordinator position. Also, the reorganization reclassifies the full time Executive Assistant to the Deputy City Administrator position to a part time Administrative Specialist position for the Administration Department.
