**RESOLUTION TO PROVIDE FOR HARDSHIP EXEMPTIONS ON SANITATION, WATER
AND STORM WATER FEES FOR THE CITY OF ROSWELL**

WHEREAS, the City of Roswell is a Georgia Municipal Corporation; and

WHEREAS, the Mayor and Council are the governing authority of the City of Roswell, Georgia;
and

WHEREAS, the Mayor and Council of the City of Roswell have established a schedule of rates for solid waste, water and storm water services from residences and commercial enterprises; and

WHEREAS, the Charter of the City of Roswell in Section Ch.6.150 provides that Mayor and Council may allow for exceptions for hardship; and

WHEREAS, the Mayor and Council have determined that it is in the public interest to have hardships for such rates, and adjust service options for such services:

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the City of Roswell, that the following rates and service options shall apply to exemptions for hardships. Such rates and service options imposed hereby shall become effective as of December 1, 2013:

1.

When the owner or renter is suffering from financial hardship, demonstrated in writing, then Hardship Review Committee may review and elect to provide an exemption from fees for up to 12 months.

2.

While the Hardship Review Committee may provide for a one-time exemption not to exceed 12 months, it is the responsibility of the owner or renter to file an affidavit at the six month period indicating the financial conditions of the original application have not changed. Failure to do so may result in loss of exemption.

3.

The Hardship Review Committee may also waive or reduce any outstanding fees, penalties and interest.

IT IS FURTHER RESOLVED that this provision for exemptions for hardship shall be in effect on the 1st day of January, 2014, or as soon thereafter as is practicable.

IT IS FURTHER RESOLVED, that the hardship exemption only applies to fees established by the Mayor and City Council of Roswell for garbage/solid waste, water, and storm water services provided by the City.

IT IS FURTHER RESOLVED, that all other fees for garbage/solid waste, water, and storm water operations shall remain in effect as currently established.
