Comparison cost for the mailing of abutting property owner notifications.

Use of stationary versus postcards. (Based on the mailing of approx. 50 notifications)

Stationary (letterhead & envelopes) \$.41 per letter plus \$.44 postage = \$42.50

Postcards \$.04 per card plus \$.28 postage = \$16.00

Difference of: \$26.50

*Note: Postcards cannot be sent to a printer for printing since the information is different for each applicant and each month. Will have to be done by staff on special paper.
