Approval of a Resolution to purchase property at 15 Oxbo Road and approval of Budget Amendment #7410CP-10-20-10 in the amount of \$197,718.

Community Development Director Alice Wakefield stated this was a request to approve a Resolution to purchase property at 15 Oxbo Road for an infrastructure improvement.
