THIS AGREEMENT is made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_, by and between the GEORGIA DEPARTMENT OF TRANSPORTATION, (hereinafter referred to as the "DEPARTMENT"), an agency of the State of Georgia, whose address for purposes of this Agreement is One Georgia Center, 600 W. Peachtree Street N.W., Atlanta, Georgia 30308, and CITY OF ROSWELL, acting by and through its Mayor and Council, hereinafter referred to as the "SPONSOR".

WHEREAS, the DEPARTMENT and SPONSOR heretofore entered into an Agreement dated July 8, 2004, hereinafter called the "ORIGINAL AGREEMENT", for the purpose of doing intersection improvements to the intersection of Hardscrabble Rd and Chaffin Rd in the City of Roswell, Georgia Department of Transportation Project Number HPP00-0000-00(265), and P.I. Number 0000265, hereinafter referred to as the "PROJECT"; and

WHEREAS, due to changes in funding arrangements, the parties mutually desire to amend the ORIGINAL AGREEMENT and delete the Exhibit A information pertaining to P.I. Number 0000265 and replace it with the information in the Exhibit A dated January 14, 2011.

NOW, THEREFORE, the parties hereto mutually agree that for and in consideration of the mutual promises, the public purposes, and acknowledgements and agreements contained herein, together with other good and valuable consideration, the receipt of which is hereby acknowledged, the parties do hereby agree to replace Exhibit A information for P.I. Number 0000265 from the ORIGINAL AGREEMENT dated, July 8, 2004, with the information in Exhibit A dated January 14, 2011.

Except as modified, changed or amended, all terms and conditions of the ORIGINAL AGREEMENT dated July 8, 2004, shall remain in full force and effect.

The covenants herein contained shall, except as otherwise provided, accrue to the benefit of and be binding up on the successors and assigns of the parties hereto.
