Landscape Compliance Issues – DRB Approved Plan

1. Two dead Dogwood trees @ tennis courts.
2. 25 – Azalea shrubs missing in tree save area south of tennis courts.
3. 10 – Azalea shrubs missing from tree save area south of softball field.
4. Planting bed missing south of softball field: 5-NRS, 7-LOR, 9-IH, 11 ABEL, 3-CRYTO.
5. 25 – Azalea shrubs missing from tree save area southwest of softball field.
6. Five dead Ash trees on berm east of new entrance drive.
7. Five dead/dying Deodar Cedar trees west of new drive.
8. Five dead Redbud trees west of new entrance drive.
9. 8 - missing Azalea shrubs in tree save area south of future H.S.
10. Planting bed missing south of existing house: 15-IH, 28-DL, 15-CPB, 179-MG, 1-RM, 25-CAR, 10-KOR, 4-CRYPT, 3-VMISC.
11. Missing 15 Azalea in tree save area south of H.S. site.
12. Planting Bed missing south of parking lot: 179-MG, 1-RM, 15-CPM, 28-DL, 15-IH, 3-VMISC, 4-CRYPT, 10-KOR, 29-CAR.
13. Missing shrub bed at entrance drive: 3-KOR, 3-NRS, 1-STH, 7-BES, 13-IH, 5-DYH, 135-ANN, 5-LOR, 5-DYH, 5-VMISC, 7-IH, 1-STH, 6-ANISE, 3-CM, 5-VMISC, 9-ANISE, 3-CM, 9-ABEL, 90-YLIR.
14. Shrub hedge along parking lot edge missing 118-NPH
15. Two dead Cryptomeria trees at main entrance.
16. Entrance planting bed missing: 3-CM, 5-VMISC, 3-ANISE, 25-CAR, 13-BES.
17. Three dead oak trees on parking lot. Missing shrubs/groundcover in islands (not counted).
18. Trees missing from area north of football field: 3-CP, 6-BG.
19. Trees missing from area east of elementary school: 3-RM, 2-CC
20. Trees missing from area south of detention pond: 6-RM, 5-BC, 5-BG, 3-SO.

Summary of Approximate #:

Dead trees: 22

Missing Trees: 55

Missing Shrubs/groundcover: 1,115

Recommend a revised landscape plan better incorporating missing plant material and reflecting current conditions be submitted to DRB for approval. Implement new approved plan in next planting season - Fall of 2011 (Oct-Dec.)
