

AFFIDAVIT OF ISHALENE MCQUILLEN

State of Georgia

Personally appeared before the undersigned officer, Ishalene McQuillen, who, being duly sworn according to law, deposes and says on oath as follows:

My name is Ishalene McQuillen and I live at 2 Meeting Street, Roswell, Georgia 30075. I have lived at this address for over five years.

I am over the age of twenty-one (21) and make these statements freely.

On March 16, 2010, I conducted a drive study using my personal T-Mobile cell phone; this cell phone is registered in my husband's name. I mapped out and traveled randomly within an approximate five-mile radius of my home at 2 Meeting Street, Roswell, GA. I estimate my home to be approximately 750-1000 yards from the proposed T-Mobile cell tower at 1060 Lake Charles Dr., Roswell, GA. I drove from approximately 10:05 a.m. to 11:50 a.m. and traveled approximately 46 miles. During this drive, I did not drop one phone call and the coverage was clear the entire time. Additionally, I left my cell phone connected to one call most of the drive which resulted in clear coverage and no disconnection of service.

The details of the drive are as follows: From 2 Meeting St., to North Coleman, to Pine Grove, to Atlanta Rd, to Northridge Rd, to Huntington Trail, to Roberts Drive, back to Roswell Rd, to Riverside Dr., to Dogwood, to Holcomb Br., to Alpharetta Hwy, to House Rd., to Crabapple Rd, to Hembree Rd (there is a water tower on this road), to Chaffin, to Crabapple Rd again, to Crossville, to King, to Hardscrapple, to Woodstock, to Mabry, to Shallowford, to Johnsons Ferry, to Bishop Lake, to Roswell Rd., to Coleman, to Willeo, to Marietta Hwy, to Mimosa, to Magnolia/Pine Grove, to North Coleman, to Woodstock Rd., to Canton St., back to Magnolia/Pine Grove, to Lake Charles, to Tollwood, to Rinsdale, back to Lake Charles, to Pine Grove to Waterford Way, back to Pine Grove, to Knoll Terrace, back to Pine Grove, to Shallowford, to Lakemont Rd, back to Shallowford, and through several neighborhoods: Shagbark, Lake Charles Plantation, Brandenburg Cr., Creekside, Land O Lakes. On a previous day, I traveled through the Chickering neighborhood and had the same experience.

Later that same evening, I made three phone calls from inside my home at 2

Meeting Street, Roswell, GA. using the same T-Mobile cell phone. The calls were completed successfully. On March 17, 2010, I made one additional call from inside my home and walked from room to room; a clear connection was made and maintained.
