On behalf of Verizon Wireless (VAW), LLC ("Verizon Wireless"), I respectfully request the City's approval of the proposed rooftop antenna mount on the existing building located at 1110 Sanctuary Parkway, Roswell, Georgia. Pursuant to the requirements of the applicable sections of the City of Roswell Zoning Ordinance, this Letter of Intent and attached Lease Exhibit provide extensive information on the proposed location of antennas and related equipment on the existing rooftop. In addition, this request will be supplemented with a Wireless Facility Application and Construction Design Package prior to the City Council meeting.

As provided in the Lease Exhibit attached hereto, Verizon Wireless intends to locate a total of twelve (12) antennas on the rooftop, with four (4) antennas on each of the three (3) skid mounts, and install a 12' x 20' equipment shelter adjacent to the existing penthouse located on the rooftop. The proposed antennas and equipment will be designed to blend in with the existing building and will not significantly change the current profile. Furthermore, the antennas will not be readily noticeable from the ground. Verizon Wireless has selected this site to ensure that increasingly relied upon wireless telecommunications service is provided in a safe and uniform

Verizon Wireless confirms that the proposed rooftop antenna mount is legally permissible, including, but not limited to the fact that Verizon Wireless is authorized to do business in the State of Georgia. As with all its facilities, Verizon Wireless will construct and operate this facility in accordance with all applicable Federal Communications Commission ("FCC") and Federal Aviation Administration ("FAA") regulations.
