**RESOLUTION TO ACCEPT A 2012 COMMUNITY DEVELOPMENT BLOCK GRANT
AWARD OF \$417,613**

WHEREAS, at the regular meeting of the Mayor and City Council of Roswell, Georgia, held on the 30th of May, 2012, a motion was made and duly seconded that the City of Roswell, Georgia agrees to accept the terms and conditions of the 2012 Community Development Block Grant (CDBG) award from the Department of Housing and Urban Development (HUD);

WHEREAS, the grant award shall be \$417,613 and the purpose of the grant is to provide funding to viable communities for decent housing, suitable living environments and economic opportunities, principally for persons of low and moderate income;

WHEREAS, the CDBG funds will be allocated to the previously approved organizations in the amounts designated in the 2012 Annual Action Plan. The organizations and amounts selected for funding are as follows:

Organization	Award Amount	Objective
Child Development Association	\$50,000	To conduct an intersection safety study in front of the CDA
City of Roswell; Grants Division	\$80,026	To hire a full-time CDBG Grants Specialist and a consultant to conduct the Analysis of Impediments Plan (AI)
City of Roswell; Rec and Parks	\$177,587	To expand the Adult Recreation Center fitness center
Drake House	\$25,000	To replace the HVAC system
HomeStretch North Fulton	\$40,000	To make housing repairs to Millbrook Circle and Roswell Commons properties
North Fulton Community Charities	\$25,000	To extend the canopy at the NFCC to shelter and preserve donated items
Senior Services of North Fulton	\$10,000	To increase transportation services for Seniors through the support of the Transportation Options Program (TOPS)
YMCA of Metropolitan Atlanta	\$10,000	To support an after school program at the Roswell facility
TOTAL:	\$417,613	

WHEREAS, the City will comply with all federal, state, and local laws and ordinances and CDBG regulations and guidance. The City of Roswell's Administration Department will be responsible for the implementation, management, reporting and close-out the grant project; and

WHEREAS, the City will not be required to provide local matching funds.
