Transportation Department - Councilmember Becky Wynn

1. Approval to initiate the right-of-way acquisition process for parcel 3 for the Oak Street Streetscape Project, Phase I, in an amount not to exceed \$40,680.

Transportation Director Steve Acenbrak stated this is the last parcel needed for this project to begin. Mayor Wood asked what portion of Oak Street will be improved and the work being performed. Mr. Acenbrak replied that the project runs along State Route 9 eastward until Bush Street. The project includes burying overhead utility lines, and the streetscape will resemble Canton Street. Mayor Wood asked how much is budgeted for phase I and the projected completion time. Mr. Acenbrak stated budget for the first phase comes from CDBG funds for \$1.8 million, and the project will be completed in 2010.
