**ORDINANCE TO AMEND THE CODE OF ORDINANCES OF THE CITY OF  
ROSWELL CHAPTER 2 "ADMINISTRATION," TO AMEND EXISTING SECTION  
2.1.4 "COMPENSATION OF ELECTED OFFICIALS," AND FOR OTHER PURPOSES**

**WHEREAS**, the City of Roswell, a municipal corporation of the State of Georgia, is authorized by Section Ch.2.20 (22) of its Charter to make, establish and adopt such bylaws, ordinances, policies, and rules and regulations as shall appear necessary for the security, welfare, convenience and interest of the city and the inhabitants thereof; and

**WHEREAS**, Section Ch.7.20 of the City of Roswell Charter provides that the compensation of the chief judge and other judges shall be fixed by resolution; and

**WHEREAS**, currently the compensation of the chief judge is set by ordinance; and

**WHEREAS**, the Mayor and Council of the City of Roswell have determined it is in the best interest of the public welfare to set the compensation of the chief judge and other judges of the municipal court of the City of Roswell by resolution:

**NOW, THEREFORE**, to accomplish the foregoing, the Mayor and Council of the City of Roswell, pursuant to their authority, do hereby adopt the following ordinance:

1.

Section 2.1.4 of the Roswell Code of Ordinances is hereby amended by deleting in its entirety the current Section 2.1.4 and substituting a new Section 2.1.4 to read as follows:

**Section 2.1.4 Compensation of Elected Officials**

Each member of the city council shall receive compensation of \$1,500.00 per month. The mayor of the city shall receive compensation of \$3,333.33 per month. The compensation of the chief judge of the municipal court shall be set by resolution of the mayor and city council. Such compensation shall be considered salary for tax purposes.

2.

Repeal of Conflicting Provisions. All ordinances, parts of ordinances, or regulations in conflict herewith are repealed.

3.

Renumbering. It is the intention of the Mayor and Council, and it is hereby ordained that the provisions of this Ordinance shall become and be made a part of the Code of Ordinances, City of Roswell, Georgia and the sections of this Ordinance may be renumbered to accomplish such intention.
