Re: City of Roswell Contract Extensions – Yard Waste Collection & Recycling
Services and Hembree Solid Waste Transfer Station Services

Dear Ms. Sealock:

The current City of Roswell contract for Yard Waste Collection and Recycling Services expires September 1, 2013. This is the first of two (2) one-year renewal options. The City of Roswell would like to exercise the second one-year option at the same prices, terms and conditions. This would extend the expiration date of this contract to September 1, 2014.

The current City of Roswell contract for Hembree Solid Waste Transfer Station Services expires December 1, 2014 with five (5) one-year renewal options. The City of Roswell would like to exercise the first three (3) one-year options all at the same prices, terms and conditions. This would extend the expiration date of this contract to December 1, 2017.

Any change to the prices within the terms of these contracts requires a formal petition by Advanced Disposal to the City of Roswell and approval by the City Council.

The above contract term extensions will be contingent on your agreement with the following conditions:

1. Advanced Disposal will conduct an additional two (2) "Bulky Trash Amnesty" events for a total of four (4) annually.
2. Advanced Disposal will complete any necessary maintenance excluding reasonably-expected wear from normal use of the Hembree Solid Waste Transfer Station building and site. Advanced Disposal will also fully repair any damage caused by their use of the facility. This work may be coordinated with the City's Public Works/Environmental Department and will include, at a minimum, spot pavement and exterior building repair.
3. Mr. Charlie Slade and Ms. Vicki Sealock, both with Advanced Disposal, will continue as the administrators for the City's contracts.
