**RESOLUTION TO ACCEPT THE FY2013 COMMUNITY DEVELOPMENT BLOCK
GRANT (CDBG) AWARD**

WHEREAS, at the regular meeting of the Mayor and City Council of Roswell, Georgia, held on the 24th of June, 2013, a motion was made and duly seconded that the City of Roswell, Georgia agrees to accept the PY13 Community Development Block Grant (CDBG) award from the U.S. Department of Housing and Urban Development (HUD); and

WHEREAS, the grant award shall be in the amount of \$452,094 in federal funds for the purpose of providing funding to viable communities for decent housing, suitable living environments and economic opportunities, principally for persons of low and moderate income; and

WHEREAS, the CDBG funds will be allocated to the previously approved organizations in the amounts designated in the 2013 Annual Action Plan along with an additional \$34,481 of unanticipated funds received from HUD for PY13. The organizations selected for funding along with their initial award amounts, additional award amounts and designated projects are as follows:
